Dear Campers,

The Formosa Lions Club and Municipality of South Bruce welcomes you back!

COVID-19 has brought many changes to how we live and play in 2020, we hope this finds you well in these challenging times. Your Health and Safety is our top priority and we have prepared these guidelines to help us all stay safe.

Please read this Code of Conduct and review it with all family members. The rules in this Code must be followed to ensure we are in compliance with Provincial or Federal Government regulations and all local health regulations.

This Code is over and above our normal campground rules, which still apply. Strict enforcement of all rules will be in place. Any camper who breaches this Code will be subject to eviction.

This code of conduct must be reviewed and signed prior to entry into the camp.

If you have a fever or flu-type symptoms, please stay home. If you have tested positive for COVID-19, are a presumptive case, or have been in contact with anyone who has tested positive or is a presumptive case, we request that you do not attempt to enter the Camps. Please remain at your residence until you have been cleared by your local health department and/or you have finished your self-isolation of 14 days.

If you are returning from travel from outside of the Province of Ontario, do not plan to visit the Camps for a period of 14 days, please remain home.

At this time, we will be operating under the following rules. These rules may change as the Ontario or Federal Government amends legislation.

Visitors

No visitors are allowed entry. Only owner's and primary residents of their residential home listed on the Booking Permit Contract will be permitted on site.

Common Areas and Facilities Closed

The following common areas are closed/restricted until further notice. All areas that are closed are indicated with a sign. If you are unsure whether something is closed or not, please contact the office for clarification.

- All washroom facilities
- Kitchen
- Playgrounds

Washroom/Kitchen Facilities in Your Trailer

All seasonal trailers must have fully functioning washroom and kitchen facilities; trailer occupancy is not permitted if any of these are deficient.

Walking around the Campground

At all times campers must obey physical distancing rules as mandated by the Province of Ontario. You must stay at least 2 meters or 6 feet away from other campers. You may use walking trails if physical distancing rules are followed.

Limit of People on a Campsite

Until such time as the Government of Ontario amends the number of people allowed to gather, we are limiting the number of people allowed on a campsite to only the people listed on the contract for that site.

Children and/or Under the age of 16

We expect that all parents will ensure their children will always obey the rules. If your children cannot follow these rules, please do not bring them to the campground at this time.

Bicycles

Unless accompanied by an adult, children will not be permitted to ride bicycles around the campground.

Events/Activities

No group events or activities are permitted at this time.

Limit of Campers in an area

Campers are expected to respect and obey all signage which restricts the number of people permitted in certain areas. Physical distancing and gathering rules must be followed. Currently no groups larger than 10.

Respect for Staff and Others

Every person has a right to expect their time at the campground will be without any type of discrimination or harassment. We will not tolerate, ignore, or condone discrimination or harassment and we are committed to promoting respectful conduct, tolerance, and diversity always.
